The account value did not exceed \$10,000 at any given time in 2010, and funds transferred into this dollar account with Guaranty Trust Bank PLC, Abuja Nigeria is for specific projects on our program goals, or small emergency funds for drill crew, and for contractor balance settlements upon job completions.

Dear Service Center Representative: Reasonable Cause Letter for late filing of RNM's 2010 Form 990EZ - Tax ID: 76-0678774 We are asking for an abatement of the penalties that will be assessed on the late filing of our 2010 990. The Organization understands the importance of reporting to the government and plans to make sure that this does not happen again. However, the staff is more knowledgeable about their duties within their service ministry than they are with tax and accounting laws. At the time the return was due the staff was dealing with the burial arrangements, equipment transitioning, and other difficult field issues following the sudden death of its rig manager (Engr. Chidi Ugochukwu Nwaonu) in Nigeria during the filing period. Since the volunteers who assist with the reporting aspects are not very skilled in tax law, they just inadvertently missed the deadline. As soon as it was realized, the return was prepared. However, the treasurer was unable to immediately assemble the financial data due to a temporary problem with the software. Please consider abating the penalties because the Organization cannot afford penalties due to the small amount of monies that it receives. All of the monies are used to help those less fortunate due to poverty, disease & ill health, and inadequate skills to provide simple clean or safe water for themselves. The action plan to ensure this does not happen again includes - setup an annual electronic reminder on our Calendars for the 990 Reporting every April 30, engaging a CPA firm to assist the ministry with tax laws & reporting requirements; and setting up a board standing Government & Compliance Reporting Committee of four to better manage this responsibility proactively. I am attaching a copy of this letter to be acknowledged with your receipt stamp and returned to me in the self-addressed and stamped envelope enclosed. I also attach a copy of two Condolence messages regarding the death of our rig manager from the Anglican Dioceses of Owerri, the Traditional Ruler of late Engr. Nwaonu's home village in Nigeria, and our current Newsletter citing the incidence.
